

Instructions: Oracle Database Customer Information Form

Due to Oracle royalty reporting rules, this completed form must accompany EVERY Primavera sales order that includes Oracle database software. **Note:** “Named-User” licenses are sold by user, not by Primavera application. Thus, if one person uses multiple Primavera products, only one named user database license is required for that user.

This form applies to:

- 1) New customers receiving Oracle database software from Primavera for the first time
- 2) Customers adding additional Primavera licenses to a system running on an Oracle database originally provided by Primavera.

Instructions:

Top section: Complete the requested sales order number and customer and Sales information.

Question 1: Choose database type and operating system.

Question 2: Identify the database server

Question 3: Select a database license type (named or CPU) and complete the appropriate fields.

Note: CPU licenses are based on the number of processors in a server. If a server has more than one processor, it requires more than one CPU license.

Examples:

- A) Customer purchases 10 P3 licenses, 20 Primavision licenses, and 50 Progress Reporter licenses for 80 individuals (i.e. – each user only uses one Primavera product). Customer has no database licenses and needs them from Primavera.

Correct Entries:

- a) 80 Total number of users
- b) -10 Number provided by Primavera (see current sales terms and conditions)
- c) -0 Customer does not have any licenses
- d) 70 Extra licenses needed
- e) \$21,000 Cost of the extra licenses ($\$300 \times 70$) (Charge the customer this amount)

Note: If all of these users are on a single server with a single CPU, it is better to purchase a single CPU license for \$14,000, a savings of \$7,000.

Note: If each person uses more than one Primavera product, the total number of users in Field A could be as low as 50 in this case.

- B) Customer purchases 10 P3e licenses, 20 Primavision licenses, and 50 Progress Reporter licenses for 80 individuals (i.e. – each user only uses one Primavera product). Customer already has purchased full-use licenses for 40 of the employees and needs the rest from Primavera.

Correct Entries:

- a) 80 Total number of users
- b) -10 Number provided by Primavera (see current sales terms and conditions)
- c) -40 Number of licenses provided by the customer
- d) 30 Extra licenses needed
- e) \$9,000 Cost of the extra licenses ($\$300 \times 30$) (Charge the customer this amount)

- C) Customer purchases 3 P3e licenses, 3 Primavision licenses and 3 Progress Reporter licenses for 3 users (each person uses all three products). Customer needs database licenses.

Correct Entries:

- a) 3 Total number of users
- b) -3 Number provided by Primavera (see current sales terms and conditions)
- c) -0 Number of licenses provided by the customer
- d) 0 Extra licenses needed
- e) \$0 Cost of the extra licenses ($\$300 \times 0$)
